Report of the NAFO Commission *Ad hoc* Working Group to Reflect on the Rules Governing Bycatches, Discards and Selectivity (WG-BDS) in the NAFO Regulatory Area Meeting

14 September 2025 Halifax, Nova Scotia, Canada

1. Opening by Chair, Deirdre Warner-Kramer (United States of America)

The Chair, Deirdre Warner-Kramer (United States of America), opened the meeting at 13:07 hours (UTC -3 hours) on Sunday, 14 September 2025, and welcomed representatives from Canada, Denmark (in respect of Faroe Islands and Greenland), European Union, Iceland, Japan, Norway, Russian Federation, United Kingdom, and the United States of America (Annex 1).

2. Appointment of Rapporteur

The NAFO Secretariat was appointed as rapporteur.

3. Adoption of Agenda

The agenda was adopted, as outlined in Annex 2.

4. Continued discussions on measures relating to directed fisheries and mitigating bycatch of moratoria species

The Chair summarized the discussions that took place during the WG-BDS meeting in July (COM Doc. 25-05) and noted that Contracting Parties expressed interest in convening another meeting of the WG-BDS in advance of the upcoming NAFO Annual Meeting. The Chair highlighted two questions to frame the discussions, whether there were any recommendations that the working group wanted to put forward to the Commission at its upcoming meeting, and what the work of the WG-BDS should look like in the coming year. The United States of America presented a working paper (COM WP 25-03) outlining additional questions to facilitate discussions.

Contracting Parties discussed the potential of asking the Commission to task the NAFO Secretariat with redoing the analysis that was completed in 2021 with the latest available data. Contracting Parties noted that there have been no indications of specific concerns that the working group would be able to request the Secretariat to explore, and that a broad scale and granular analysis would create a significant workload for the Secretariat. Those Contracting Parties questioned whether the results of such a broad analysis would highlight or address any specific concerns. Contracting Parties reflected on the recent adoption of measures relating to bycatch for specific fisheries. Some Contracting Parties expressed that the need for these multiple specific measures reflects an underlying issue with the way the overall bycatch measures are written, while other Contracting Parties noted that the fishery specific measures reflect the dynamic nature of NAFO fisheries and its flexibility to adapt. It was also noted that STACTIC will be reviewing the specific measures adopted for bycatch of American plaice in the 3LNO yellowtail flounder fishery and for bycatch of redfish in the 3M cod fishery as part of their work at the upcoming Annual Meeting, and the results of those discussions could better inform next steps for the WG-BDS.

The working group agreed that there were no specific recommendations to forward to the Commission and that any future work for the working group should be discussed at the Commission following the results of the discussions in STACTIC during the upcoming Annual Meeting.

5. Other Business

No other business was discussed.

6. Time and place of next meeting

The working group will not be scheduled to meet again unless clear tasking is assigned by the Commission.

7. Adoption of Report

The report was adopted via correspondence following the end of the meeting.

8. Adjournment

The meeting was adjourned at 14:01 hours (UTC -3 hours).
