## Performance Review Recommendation #36: Design a new visual identity for NAFO

## Preamble

As noted in STACFAD WP 23-11, further refined potential logo options were circulated to the focus group and STACFAD members in STACFAD WP 23-01 (Rev.) seeking feedback. The feedback was received from three (3) Contracting Parties and is provided below:

Canada	In general, we are pleased with the direction we're headed in for a refresh of the current logo and appreciate the work the Secretariat has put in. We feel that combining some of the elements presented (particularly from 3.7B and 3.9B) would be helpful. To inform our discussions at STACFAD, it would also be useful to see how the potential logo(s) look in black and white as well, since it will often be printed that way. From <b>3.7B</b> , we like:			
	<ul> <li>the font – it is clear and easy to read (though we're open if other CPs have preferences, just not the fonts in 3.8A and 3.9B),</li> </ul>			
	• the location of the text (acronym within the "porthole" above the boat and the full name below the picture),			
	<ul><li>the "porthole" without a second/interior circle, and</li><li>the style and colour of the waves (fine with 3.7A as well).</li></ul>			
	From <b>3.9B,</b> we like:			
	• The vessel design (general preference for this one, though could fish be closer to the bottom, which differentiates NAFO from other types of fisheries/RFMOs (say tuna). Could be one or two fish, potentially a bit less simplistic to match the more detailed vessel?			
Denmark (in respect	DFG prefers logo option <b>3.7A and 3.7B</b> . We are satisfied that the fish in back in the logo. We do feel that there might be too many color variations in the logo. Perhaps it is possible to tone down the green color and remove one color in the logo.			
of the Faroe Islands and Greenland)				
European union	Our visual identity preference would be consequently for <b>3.9B</b> , <b>3.7A</b> and <b>3.7B</b> .			

All three respondents included logo option 3.7B in their top preferences. For that reason, the NAFO Secretariat refined logo option 3.7B, as presented in STACFAD WP 23-01 (Rev.) using the feedback provided.
