

46th ANNUAL MEETING - SEPTEMBER 2024

Scientific Council Additional Requests to the 2025 Budget Estimate (Prepared by the NAFO Secretariat)

Background Information

At the June 2024 Scientific Council Meeting in Halifax, Nova Scotia, Scientific Council considered the draft budget for 2025 provided by the Secretariat (NAFO/SCS Doc. 24-16 Revised, pg. 80).

The Scientific Council noted two significant additions to their routine budget requests, specifically:

- 1. Increase funding to support participation in the joint FAO/ICES/NAFO Symposium
- 2. Funding to hire a dedicated analyst for one year

The Secretariat was tasked with calculating the estimated costs for these items.

Joint FAO/ICES/NAFO Symposium

The joint FAO/ICES/NAFO Symposium "Applying the Ecosystem Approach to Fisheries Management in ABNJ" is taking place 11-13 March 2025 in Rome, Italy.

At the last Annual Meeting, the sponsorship by NAFO to the joint Symposium was anticipated to be CAD \$15,000 and was included in the 2025 Budget Forecast. At its meeting in June 2024, the Scientific Council noted the importance of Scientific Council members attending the joint FAO/ICES/NAFO Symposium "Applying the Ecosystem Approach to Fisheries Management in ABNJ" and it was recommended that the following representatives should attend:

The travel costs for 11 SC representatives (5 from North America and 6 from Europe) is estimated to be CAD \$30,000, exceeding the CAD \$15,000 previously included in the 2025 Budget Forecast.

• The 2025 Budget Estimate would need to be increased by an additional CAD \$15,000 under the Intersessional Scientific Meetings budget item to accommodate this request from SC.

Please note, these funds are intended to cover representation from SC only, if representation from other NAFO bodies (i.e. the Commission) is required, the budget would need to be further increased to accommodate that cost.

Hire a dedicated analyst for one year

Additionally, in relation to the workload, the Scientific Council requested funding be made available to hire a dedicated analyst to contribute both to the Management Strategy Evaluation for 3LN redfish and other analytical work of the Scientific Council for one year.

The Secretariat recently contracted experts to assist in the NAFO Precautionary Approach Framework (PAF) review. The rate that was provided to these experts was approximately CAD \$900 daily. Using an estimated 250 working days in a year, the cost to hire a dedicated analyst for one year to contribute to the work of the Scientific Council is estimated to be CAD \$225,000 (CAD \$900 x 250 working days).

Please note, this matter is being discussed under agenda item 16.c "Other issues as determined by the Chairs of the Commission and the Scientific Council" at the joint Commission-Scientific Council session of the 2024 Annual Meeting of NAFO.

• The 2025 Budget Estimate would need to be increased by an additional CAD \$225,000 under the Additional Help budget item to accommodate this request from SC.

For STACFAD's consideration and review, the NAFO Secretariat has provided a revised 2025 budget estimate (Annex 01) and preliminary billing forecast (Annex 02) reflecting the addition of the two above budget requests.
