

### A YEAR IN REVIEW

The 2015 Annual Report provides an overview of NAFO's activities and accomplishments for that year, which proved to be very busy.

NAFO has continued to be a leader amongst regional fisheries management organizations (RFMOs) in measures to protect marine ecosystems. At the September 2015 Annual Meeting, held in Halifax, Nova Scotia, NAFO decided to prohibit all bottom fishing on seamounts in the NAFO Regulatory Area (NRA). Combined with similar measures already in place to protect vulnerable marine ecosystems (VMEs), about 380,000 square kilometres of the NRA are now closed to bottom fishing. NAFO also made further progress in the development and implementation of its ecosystem approach to fisheries management, including further development of its ecosystem 'roadmap'.

In 2015 there was further evidence that the stocks regulated by NAFO are becoming healthier, although a number of these stocks continue to be under fishing moratoria. At the Annual Meeting it was agreed that the cod and redfish stocks on the Flemish Cap (Div. 3M) and the Witch flounder ('grey sole') stock on the Grand Bank could support an increase in catches over the next two years. Additionally, NAFO has continued to improve compliance and enforcement in the northwest Atlantic by agreeing to the addition of technical measures, such as follow-up to infringements, in the NRA.


Throughout the year, NAFO joint Fisheries Commission (FC) and Scientific Council (SC) Working Groups continued to prove productive. These joint FC-SC meetings have focussed on the development of risk-based management strategies for particular fish stocks, the implementation of the ecosystem approach to fisheries management, improving the quality of catch statistics and improving the NAFO rules on by-catches, discards and selectivity. In 2015, another joint group was established, the joint FC-SC Catch Data Advisory Group, intended to ensure the representativeness of various sources of data for validating catch and/or developing catch estimates.

This year continues to be one of transition at the Secretariat. NAFO had to say good-bye to its Scientific Council Coordinator, Dr. Neil Campbell, who returned to Scotland after the Annual Meeting after serving NAFO for five years. We thank Neil very much for his dedicated service to NAFO, particularly the Scientific Council, and wish him every success in his future endeavours. Neil's replacement, Mr. Tom Blasdale, also from Scotland, will commence his duties in 2016. NAFO also had to say good-bye to two further members of the Secretariat staff and founding members of STACFEM, Barb Marshall and Cindy Kerr, who decided to retire after over 35 years of dedicated service to the organization. NAFO wishes them all the best. NAFO welcomed two very capable replacements, Jana Aker as NAFO's new Fisheries Information Administrator and Dayna Bell as NAFO's new Scientific Information Administrator.

#### Other highlights of 2015 include:

- NAFO began preparing for its second Performance Review with the establishment of a working group to determine its terms of reference and timing. All but two of the recommendations from NAFO's first Performance Review in 2011 have been addressed;
- In the context of increasing oil and gas activity in the NAFO Regulatory Area, NAFO accepted in principle an information exchange mechanism to ensure the smooth co-existence of these activities with fishing activities and fisheries research in the NRA;
- NAFO published an update to its Coral, Sponge and Other Vulnerable Marine Ecosystem Indicator Identification Guide, NAFO Area;
- NAFO has managed to be about \$80,000.00 under budget.
- NAFO continues to participate actively in various initiatives of the United Nation's Food and Agriculture Organization (FAO) including co-hosting in Halifax in October 2015, with Dalhousie University's School of Management Studies, the annual meeting of the Advisory Board of Aquatic Sciences and Fisheries Abstracts (ASFA), for which the FAO provides the Secretariat. NAFO's Executive Secretary also chaired the first Project Steering Committee meeting in Rome in

December 2015 of the partners of the Areas Beyond National Jurisdiction (ABNJ)

# **GENERAL COUNCIL**

#### FINANCIAL STATUS UPDATE


The **Standing Committee on Finance and Administration (STACFAD)** oversees the budget and administrative matters of the Organization. At the Annual Meeting in Halifax, Nova Scotia, Deirdre Warner-Kramer (USA) led the committee throughout its deliberations.

STACFAD was pleased to report that the overall financial affairs of the Organization continue to be in a very good financial position. The NAFO budget for 2015 was increased to \$1.981 million as additional supplementary payments were required to pay down the NAFO Pension Plan deficit. The Secretariat has been working prudently to stay within the approved budget and ended the 2015 fiscal year approximately \$80,000 under budget. Operating cash at year end was also at a high level with only one membership contribution of \$31,880 outstanding. The Committee put forward a budget proposal for the 2016 fiscal year of \$1.997 million, representing an increase of 0.8% over the 2015 approved budget.

W|B|L|I Chartered Accountants performed the audit of the 2014 financial records for the fourth year and the statements were approved by the Organization at the September 2015 Annual Meeting.


At the 2014 NAFO Annual Meeting, the General Council tasked STACFAD to review the existing NAFO Secretariat classification scheme, including salary scales and relevant employment benefits' to improve efficiency and support the priorities of the Organization and its Contracting Parties. Stephen MacDermott, SJM Consulting, was selected to perform the review and presented a draft report to the Committee. The Committee and NAFO Staff Association requested additional detail and analysis and recommended a revised report be presented at the 2016 Annual Meeting.

The next meeting of STACFAD will be held during the 2016 Annual Meeting of NAFO in Varadero, Cuba.



### STATUS OF RATIFICATION

In 2015, seven Contracting Parties had completed the ratification process for the NAFO amended Convention. NAFO needs nine of the twelve Contracting Parties to ratify the amended Convention in their own parliaments before it can become a legally binding instrument.




Fig. 1. The NAFO Vulnerable Marine Ecosystem (VME) Protection Areas

#### SPONGE/CORAL AND SEAMOUNT PROTECTION AREA

In 2015, the Fisheries Commission removed the possibility of conducting exploratory bottom fishing in the seamount protection areas, thereby making all NAFO protective areas closed to all kinds of bottom fishing activity (Fig. 1).

### JOINT FISHERIES COMMISSION-SCIENTIFIC COUNCIL WORKING GROUPS

In 2013, three joint Fisheries Commission-Scientific Council Working Groups (FC-SC WGs) were established in response to the 2011 Performance Review recommendations. Not only do these Working Groups provide a forum for an improved dialogue between fishery managers and scientists, but they address major issues concerning ecosystem approach to fisheries management, risk-based management strategies and catch reporting in a more holistic manner. In 2015, these WGs continued to meet and provided recommendations to FC and SC relating to the general objective of long term conservation, sustainable use of fishery resources and the safeguard of the marine ecosystems.

Documents and reports from the joint WGs are archived in a new series of documents entitled FC-SC Documents.

#### **OTHER WORKING GROUPS**

In addition to the joint WGs mentioned above, the ad hoc Fisheries Commission Working Group on Bycatches, Discards and Selectivity (WG-BDS) met and developed an Action Plan to address bycatch issues, which was adopted by Fisheries

Commission. Within the Standing Committee on International Control, two *ad hoc* WGs were created. The *ad hoc* WG to Review the NAFO Observer Scheme (STACTIC) met to conduct a Strengths, Weaknesses, Opportunities and Threats (SWOT) analysis of the Observer Scheme; and the *ad hoc* WG on Port State Control Alignment met to revise and align the exiting port State measures with the FAO *Agreement on Port State Measures to Prevent, Deter and Eliminate Illegal, Unreported and Unregulated Fishing*.

#### **FISHERY TRENDS**

NAFO identifies three main fisheries in its Regulatory Area: groundfish (GRO – primary in Divs. 3KLMNO), shrimp (PRA – traditionally in Divs. 3L and 3M), and pelagic redfish fisheries (REB – primarily in Divs. 1F and 2J). The last two have been under moratorium. Limited effort on pelagic redfish fishery was exerted by one Contracting Party which formally objected to the pelagic redfish fishery moratorium.




Fig. 2. The percentage of fishing effort (based on the number of days) in the NAFO Regulatory Area in 2015.

In 2015, there were 57 fishing vessels spending a total of 4 209 days in the NAFO Regulatory Area (Table 1) and 138 trips were identified. Groundfish fisheries accounted for 98% of the fishing effort (in terms of fishing days in the NRA) (Fig. 2).

For the period 2004–2015, the overall fishing activities in the NRA show a declining trend, from 134 active vessels in 2004 to 57 in 2015. The decline in terms of overall fishing days was a decrease for the same period from 16 480 days in 2004 to 4 209 days in 2015. The average number of days each vessel operates in the NAFO Regulatory Area also declined from 123 days in 2004 to 74 days in 2015.





Fig. 3. The number of active vessels (top graph) and the fishing effort (bottom graph) trends from 2004 to 2015 for the groundfish (GRO) and pelagic redfish (REB) fisheries. There was no effort on shrimp (PRA) fisheries in 2015.

Figure 3 illustrates the changes described above for each of the major fisheries. The general decline in fishing effort since 2004 is observed for the three fisheries, with pelagic redfish fishery being close to disappearance in 2009 and resurging in 2012 with a slight decline in 2014 and 2015. NAFO fisheries remain dominated by the groundfish category.

#### **COMPLIANCE**

The Joint Inspection and Surveillance Scheme is implemented to ensure compliance of NAFO-registered fishing vessels in the NAFO Regulatory Area. Inspectors are appointed by Contracting Parties and assigned to fishery patrol vessels tasked to carry out inspection duties at sea. In 2015, Canada and the European Union continued to deploy inspection vessels in the NRA.

In all, 110 at-sea inspections were conducted on the vessels in 2015. From these inspections, only one Apparent Infringement (AI) was detected. It concerned retaining on-board a quantity of moratorium species above the allowable limit. As required by the *NAFO Conservation and Enforcement Measures* (NCEM), the Contracting Party of which the vessel belongs reported that it initiated the court proceedings on this AI case.

# SCIENTIFIC COUNCIL

#### **STOCK STATUS**

NAFO's Scientific Council met during 29 May–11 June 2015 at Saint Mary's University in Halifax, Nova Scotia, Canada, to produce advice to the Fisheries Commission and Coastal States on the status of fish stocks, the implementation of NAFO's Roadmap to an Ecosystem Approach, significant adverse impacts on vulnerable marine ecosystems and the issue of fisheries on seamounts.

On the Flemish Cap, assessments of cod and redfish revealed both stocks to be in a healthy condition. On the Grand Bank, an analytical assessment of the Witch flounder stock was adopted, allowing the development of precautionary reference points for fishing mortality and biomass of this stock. The stock of cod on the south of the Grand Bank continues its long road to recovery. Despite signs of an upturn in recent years, poor recruitment of young fish to the population is now holding back recovery and this cod stock remains well below its precautionary reference level. The Council also considered the work done by the Working Group on Ecosystem Science and Assessment (WG-ESA). This year, WG-ESA developed indicators of primary productivity for bioregions of the northwest Atlantic, and from those inferred "catch ceilings" which such levels of productivity would support.

In September, the Council met in St. John's, Newfoundland to advise on the status of shrimp stocks. Shrimps on the Grand Bank and Flemish Cap continue to be at low levels, with little sign of any recovery. The group paid tribute to its former member, Dave Orr, who sadly passed away over the summer.

#### **FISHERIES & ENVIRONMENT**

The North Atlantic Oscillation index (NAO), a key indicator of climate conditions over the North Atlantic, returned to a strongly positive phase in 2014 (anomaly of 11.5 mbars or 1.3 Standard Deviations (SD) above normal) representing a strong arctic air outflow in the northwest Atlantic during the winter months and consequently lower than normal winter air temperatures. The annual mean air temperature at Nuuk Weather Station in West Greenland was -0.6°C in 2014, 0.8°C above the long term mean (1981-2010). During the winter convection season, surface air temperatures in the Labrador Sea were 1-3°C above normal but late winter was below normal. There was a significant decrease in winter air temperatures (-0.6 to -1.0 SD below normal) over much of the NL region compared to 2013. Annual air temperatures over Labrador (at Cartwright) were near normal and slightly above normal (0.4 SD) over Newfoundland (at St. John's). 2014 was ranked as the 15th warmest year (air temperature) for the 115 year time series for the Scotian Shelf and Gulf of Maine. With the exception of Boston (-0.3°C and 0.4 SD) all other sites experienced warmer annual temperatures than normal, from just slightly positive in St. John's.





#### **ECOSYSTEM APPROACH**

The Scientific Council Working Group on Ecosystem Science and Assessment (WG-ESA) met for their 8<sup>th</sup> meeting, 17–26 November, at the NAFO Headquarters in Dartmouth, Nova Scotia, to address requests for advice and its standing terms of reference. Over the course of the meeting many items were addressed including the ecosystem "roadmap" and the assessment of impacts other than fishing, as well as significant adverse impacts (SAI) on vulnerable marine ecosystems.

The Coral, Sponge, and Other Vulnerable Marine Ecosystem Indicator Identification Guide, NAFO Area was released in October 2015. This comprehensive guide is a follow-up to both the 2009 NAFO Coral and 2010 NAFO Sponge Identification Guides.

Executive Secretary, Fred Kingston, attended the Workshop on Linking Global and Regional Levels in the Management of Marine Areas Beyond National Jurisdiction in Rome, Italy during the 17-20 February. During the meeing, Mr. Kingston delivered a presentation on NAFO's development of its ecosystem approach framework to fisheries management.

#### FAO FIRMS Steering Committee Meeting—9th Session

The 9<sup>th</sup> session of the **FIRMS Steering Committee** took place in Namibia 23-27 February, where Secretariat staff member, Neil Campbell (NAFO SC Coordinator), was elected Chair, replacing Barbara Marshall (NAFO's Senior Information Officer). FIRMS is now focusing on encouraging additional memberships in order to have a worldwide coverage, and additionally, to revamp current outreach. The next meeting aims to take place in early 2016 with the location still to be determined.

#### FAO CWP on Fishery Statistics-25th Session

This Coordinating Working Party (CWP) of the FAO held an intersessional meeting of the fisheries group for fishery statistics during the 23–27 February in Namibia. The CWP developed a new focus for the working party as a repository for standards in fisheries statistics. A strategy to ensure that the next meeting (April 2016) is quorate has been developed. During the meeting, there was also a focus on the clarification of fishery commodity codes to align with World Customs Organisation Central Product Classification Codes, and on the identification of fisheries, in conjunction with FIRMS.

### FAO ABNJ Project—Workshop on VME Process and Practices

In 2013, NAFO was invited to partner in the **FAO-Global Environment Facility (GEF) Project**, "Sustainable fisheries management and biodiversity conservation of deep-sea living marine resources and ecosystems in the Areas Beyond National Jurisdiction (ABNJ)".

This year, a meeting was held 2–4 March in Namibia under the auspices of the FAO ABNJ Deep Seas project, that aimed to identify and document best practices surrounding VMEs in RFMOs. Participants from the Secretariats and scientific bodies of CCAMLR, SPRFMO, NEAFC, NAFO, GCFM and SIODFA attended, including two members of the NAFO Secretariat.

Executive Secretary, Fred Kingston, has also agreed to be the liaison for NAFO for the ABNJ Project's Community of Practice on Fisheries, Biodiversity and Climate Change.



### International Fisheries Commissions Pension Society (IFCPS) Annual Meeting

The annual meeting of the International Fisheries Commissions **Pension Society (IFCPS)** was hosted by the Department of Fisheries and Oceans Canada during 14-16 April 2015 in Ottawa, Ontario, Canada. The meeting was attended by representatives of the seven International Fisheries Commissions with headquarters located in Canada and the United States of America. Also attending the meeting were the IFCPS directors appointed by the Governments of Canada and the United States. NAFO was represented by Fred Kingston, Executive Secretary, and Stan Goodick, Deputy Executive Secretary/Senior Finance and Staff Administrator. Discussions focused on the performance of the pension plan investments which for 2014 was 12.5% (gross of fees). This was well in excess of the 5.5% return target. The 2016 annual meeting of the IFCPS will be hosted by the International Pacific Halibut Commission during 19-21 April 2016 in Seattle, Washington, USA.

#### **JASCO Applied Sciences**

In July, the Executive Secretary and the Fisheries Information Administrator from the Secretariat met with JASCO Applied Sciences in Dartmouth, Nova Scotia, Canada.

JASCO is an acoustic monitoring company that is currently deploying several acoustic sensors throughout the NAFO Convention Area, one of which has been deployed in the NAFO Regulatory Area during the summer of 2015. The sensors deployed are part of a Canadian Environmental Studies Research Fund (ESRF) project that is funding research with the purpose of determining seasonal locations of marine mammals and potentially detecting groundfish spawning areas.

The Secretariat briefed JASCO about NAFO and JASCO will remain in contact with the NAFO Secretariat throughout the remainder of the project.

#### **ASFA**

The 44<sup>th</sup> Annual Meeting of the **Aquatic Sciences and Fisheries Abstracts (ASFA)** Advisory Board was co-hosted by NAFO and Dalhousie University's EIUI group, and took place from 5–9 October 2015 at Dalhousie University, Halifax, Nova Scotia, Canada. The meeting was opened by Mr Fred Kingston, Executive Secretary, NAFO, and Dr. Bertrum MacDonald, Acting Dean, Faculty of Management, Dalhousie University. The Meeting was attended by 33 participants, representing 26 ASFA Partners and four observers. Mr Pettman (Freshwater Biological Association) chaired the meeting and the agenda was completed on time. The main rapporteur was Ms. Wibley (FAO-ASFA Secretariat) and Ms. Pacey (NAFO) was assistant rapporteur.

All of NAFO's publications and documents are indexed in the ASFA Database, which provides the most comprehensive information to a

global audience for abstracting and indexing services in the aquatic and fisheries field. ASFA's ability to provide deep indexing, links to full text and the indexing of 'grey literature', ensures documents, publications and general information pertaining to aquatic sciences and fisheries is available to a wide audience.

In 2015 Suzuette Soomai, PhD doctoral student who had an internship with NAFO in 2013, completed her research and defended her dissertation in the summer of 2015. The relationship between NAFO and the School for Information Management at Dalhousie, due to common interests, has led to co-hosting the annual Aquatic Sciences and Fisheries Abstracts (ASFA) meeting this past autumn in Halifax, NS.

In addition, Suzuette made a presentation at the WG-ESA meeting highlighting the results of her research regarding the use and policy relevance of marine scientific information.

NAFO will continue to support the EIUI team as new funding from the SSHRC Insight program is approved and new case studies and new students enhance the on-going partnership.

#### IT

#### **Security and Auditing Policies**

This year, in what is an ongoing process, the Secretariat continued to look at how to secure and safeguard NAFO's data. To increase security, the IT team began with the creation of more documents aimed at data classification. This will ensure that all data is organized to specify the needs of each member and working group.

#### **Server Room**

This past year, the Secretariat worked on streamlining backup processes, as well as moving an additional server into the virtualized environment. Additionally, new virtual servers for SharePoint, communicating with the EU and web services were added.

#### **Email**

In 2015, the NAFO Secretariat moved to a hosted online email service which helps with backup, business recovery, remote access, budgeting, and security.

#### **Increased use of electronic files**

The NAFO Secretariat continues to investigate the best ways to increase the use of electronic files. Electronic files are portable, cost-effective and environmentally friendly.

Pre-meeting documentation is provided on the NAFO Members' pages and NAFO Meetings SharePoint site in place of paper copies. At the Annual Meeting, pre-meeting documentation was also provided at registration on electronic flash drives.

#### **NAFO** Webpages

The NAFO Secretariat web team has undertaken a large project to migrate the NAFO web pages to a content management system (CMS) in order to upgrade the functionality of the website and streamline content. The new website will also have a slightly modified look and feel that will appear modern and up-to-date. The members' pages will be upgraded and overhauled to maximize transparency and ease of use for all CPs. Some CPs offered to be part of the NAFO web team in order to provide feedback on the large project. The website will be unveiled for critical review and feedback at the Scientific Council Meeting in June 2016 and will implement changes that arise from the meeting. Many of the comments and suggestions that the NAFO Secretariat has received from surveys, comments and emails over the past five to six years regarding the current site were taken into account when designing the new platform. The website will be showcased at the 38th Annual Meeting in Cuba for all participants to view and interact with, and hopefully it will have addressed many of the concerns that NAFO members have had in the past with the NAFO web pages.

#### **JNAFS Website**

Development of a new website for the *Journal of the Northwest Atlantic Fishery Science* was completed in May 2015 for presentation at the Scientific Council Meeting in June. It was well received and it continues to be modified slightly to enhance the information found on the site.





#### **Publications**

In collaboration with the WG-ESA (Scientific Council Working Group on Ecosystem Science and Assessment), the publications department published the Coral, Sponge, and Other Vulnerable Marine Ecosystem Indicator Identification Guide, NAFO Area in October 2015. This edition is a combination of the 2009 NAFO Coral Identification Guide and the 2010 NAFO Sponge Identification Guide with the addition of newly discovered VME indicator species. The new book is printed on water resistant and tear-proof paper and inserted in a polyvinyl binder. Any future changes or new species that are discovered can be inserted in the binder.

During the period of January 2015 – December 2015, in addition to the many meeting documents and working papers for NAFO meetings, the NAFO Secretariat prepared, posted to the web and/or printed the publications listed on the right.

#### **Other Projects, Initiatives and Responsibilities**

The Senior Publications Manager, Alexis Pacey, in addition to managing the publications at NAFO, also manages the NAFO website. It is an added responsibility that Alexis has undertaken with enthusiasm since Senior Information Office, Barb Marshall, retired in March 2015.
