Fishery Statistics and other outstanding issues

The statistical NAFO database is computerized at the NAFO Secretariat and available for the Contracting Parties.

STATLANT 21A reports (annual catches in the NAFO Convention Area by species and divisions), are outstanding from: 1990 - EU-Fra(M); 1994 - Cuba, Korea and Lithuania (reporting date 15 May).

STATLANT 21B reports (annual catches in the NAFO Convention Area by species, month, effort), are outstanding from: 1989 EU-Fra (M); 1990 - EU-Fra (M) and Fra-SP; 1991-1992 - Fra-SP; 1993 - Denmark (Faroes), EU-Portugal, Fra-SP and Norway. For 1994, STATLANT 21B reports have been received only from Canada-N, Estonia, EU-Fra (M), Iceland, Japan, Poland and Russia (reporting date 30 June).

Major NAFO substantive issues and decisions through 1994

- a) The General Council resolved:
 - Republic of Korea admitted to the Fisheries Commission (September 1994);
 - To begin a regular semi-annual publication of a NAFO Newsletter "NAFO News";
 - To delegate a NAFO observership at NAMMCO (North Atlantic Marine Marimal Commission) to Norway and at the UN Conference on the High Seas Stocks, to Denmark (in respect of the Faroe Islands and Greenland);
 - To adopt Resolution 94/1 on fishing activities of Non-Contracting Parties in the NAFO Regulatory Area calling for acceptance of "Agreement to Promote Compliance with International Conservation and Management Measures by Fishing Vessels on the High Seas";
 - To present all NAFO proposals which potentially could have an impact on the NAFO budget with cost estimates for those proposals.
- b) The Fisheries Commission resolved;
 - To extend the NAFO Observer Scheme Pilot Project for 1995;
 - To continue discussions on improvements to the NAFO Conservation and Enforcement measures at the 17th Annual Meeting with respect to: inspections, reporting of catch on board of fishing vessels, mesh size and fish size, port inspections, effort plans and catch reporting, apparent infringements and follow-up on them, pilot project for observers and satellite tracking;
 - To adopt the following TACs for regulated stocks in the Regulatory Area for 1995: Cod in Div. 3M-11000t; Redfish in Div. 3M-26000t; Redfish in Div. 3LN-14000t; Squid in Subareas 3+4-150000t; Greenland halibut-27,000;
 - To impose "no directed fishing" for the following stocks: Cod in Div. 3NO, A. plaice in Div. 3M and 3LNO, Yellowtail flounder in Div. 3LNO, Witch flounder in Div. 3NO, Capelin in Div. 3NO, and Cod in Div. 3L of the Regulatory Area.
 - To introduce regulatory measures for shrimp fishing in Div. 3M (bar space 22 mm, by catch 5%, minimum mesh size 40 mm), and *no directed fishing* in 3LNO.
- c) The Scientific Council recommended:
 - On stock assessments, the summaries and conclusions for each stock were formulated in NAFO SCS Doc. 95/19, Section X;
 - On coordination of surveys, a synoptic survey for Greenland halibut was recommended;
 - Analyses of distribution and abundance of non-traditional species be conducted for the extensive survey database and presentation to the Scientific Council in 1996;
 - On fishery statistics, the Assistant Executive Secretary should attend the ad hoc consultation planned for July 1996 in Rome and 17th Session of CWP in Hobart, Australia;
 - To make NAFO presentation and presence at 2nd World Fisheries Congress to be held 28 July 02 August 1996 in Brisbane, Australia;

Note: These two (2) last events if approved by STACFAD would require an allocation of extra funds to the NAFO annual budget in the range of \$15,000 Cdn.

For Internet communication between the NAFO Secretariat and scientists, there should be e-mail arrangements at the Secretariat.

Note: This idea had been explained to Contracting Parties in GF/93-408 of 03 November 1993 and GF/94-012 of 04 January 1994. The total cost of this project is expected to be in the range of \$4500 Cdn. (a one time cost) and then user fees approximately \$300-350 Cdn annually.
