Other initiatives and work:

Journal of Northwest Atlantic Fishery Science (JNAFS)

Development of the new website for the *Journal of the Northwest Atlantic Fishery Science* was completed in May 2015 for presentation at the Scientific Council Meeting in June 2015. It was well received and it continues to be modified slightly to enhance the information found on the site. Other features in the future may include an online submission process as well as enhancing the downloadable references/citations for journal articles.

Aquatic Sciences and Fisheries Abstracts (ASFA)

All of NAFO's publications and documents are indexed in the ASFA Database, which provides the most comprehensive information to a global audience for abstracting and indexing services in the aquatic and fisheries field. ASFA's ability to provide deep indexing, links to full text and the indexing of 'grey literature', ensures documents, publications and general information pertaining to aquatic sciences and fisheries is available to a wide audience.

For 2015: 59 Scientific Council Research (SCR) documents for 2015 got indexed. Every individual article that is published in the Journal of the Northwest Atlantic Fishery Science gets indexed, in addition to the Scientific Council Studies, the CEM, Meeting Proceedings, Scientific Council Reports and the Annual Report. SCS documents are being added to the database starting with the most recent and working back.

New publication published in October 2015

Coral, Sponge, and Other Vulnerable Marine Ecosystem Indicator Identification Guide, NAFO Area

This is a continuation of the previous *Coral Identification Guide NAFO Area* and *Sponge Identification Guide NAFO Area* that were published in 2009 and 2010, respectively, to include more VME indicator species. This guide uses a waterproof binder with water resistant pages that can be inserted as more VME indicator species are discovered. This initiative was the result of the WG-ESA meeting in November 2014. A group of authors and contributors collaborated with the publications department on the new book. It was presented at the 2015 WG-ESA meeting in Halifax, Nova Scotia, Canada.

6. Fishery Statistics

The NAFO statistical databases are compiled by the NAFO Secretariat and published on the NAFO web site http://www.nafo.int/data/frames/stats. They are continuously updated as soon as new submissions are received.

The 21A Extraction Tool, available on the NAFO website, continues to be used to query the NAFO Statistical database. This tool provides fishery catch statistics organized by country, species, division and year from 1960 to the present.

7. Information Technology (IT)

Security

In 2016, the Secretariat implemented two important measures on the security front. First, a new advanced firewall appliance was installed. This not only vastly increases our defence against possible outside threats but also incorporates sophisticated logging and tracking of data to and from the Internet. Secondly all laptops that leave the Secretariat office with NAFO data on them will be encrypted to help protect our data.

Electronic Communication

An electronic communication transfer system was implemented between one Contracting Party and the Secretariat to help automatically receive important data. Prior to this system the information was sent and processed manually. This system will continue to be advanced going forward for even better benefits.

8. The NAFO Webpages

New NAFO website - public and members

The NAFO Secretariat web team has undertaken a large project to migrate the NAFO web pages to a content

management system (CMS) in order to upgrade the functionality of the website and streamline content. The new website will also feature a modified look and feel that will appear modern and up-to-date. The Members' pages will be upgraded and overhauled to maximize transparency and ease of use for all Contracting Parties.

Some Contracting Parties offered to be part of the NAFO web team in order to provide feedback on the large project. The website was unveiled for critical review and feedback at the Scientific Council Meeting in June 2016. It was suggested that members provide feedback by the end of July so they can be implemented. Many of the comments and suggestions that the NAFO Secretariat has received from surveys, comments and emails over the past five to six years regarding the current site were taken into account when designing the new platform. A presentation of the website will be done the 38^{th} Annual Meeting in Cuba for all participants to view.

Inspection Website

In the last several years, NAFO has embarked on comprehensive development of a secure NAFO Inspectors website (MCS website). Inspectors assigned to the NAFO Joint Inspection and Surveillance Scheme are able to access information relevant to fishing vessels operating in the NAFO Regulatory Area. There is currently a proposal to expand the capacity of the MCS website to include all data sources (e.g. Observer Reports, Port Inspection Reports, Vessel Transmitted Information, etc.) so that Contracting Parties with an Inspection Presence would be able to readily access all of this information from a central hub. This proposal will be discussed at STACTIC during the 2016 Annual Meeting.

SharePoint

The NAFO SharePoint continues to be a valuable resource allowing access to the meeting documentation before, during and after meeting hours (meetings.nafo.int). The NAFO Secretariat continues to investigate the best ways to increase the use of SharePoint technology during meetings.

WebEx

This year, there was an increase in virtual meetings using the online meeting tool, WebEx (www.webex.com). WebEx allows meetings to take place anywhere, anytime, with meeting participants at various locations, as well as allows participants to participate in non-virtual meetings that they cannot attend.

9. Staff Committee

The Secretariat would like to thank Emilia Batista, Joanne Morgan and Deirdre Warner-Kramer for serving on the Staff Committee for the 2015-2016 term. The Staff Committee did not need to meet during the past 12 months.

10. Secretariat Activities

NAFO Internship Program

At the 2011 Annual Meeting, a NAFO Internship Program was adopted by the Organization. Since then, eight interns have taken part in the program. This year, two interns participated in the NAFO internship program.

Yumi Okochi

Yumi arrived at the NAFO Secretariat for a three-month internship from mid-May to mid-August 2016. She hails from Japan and was previously working on Pacific bluefin tuna biological studies at the National Research Institute of Far Seas Fisheries, Fisheries Research Agency Japan, as an associate researcher. During the course of her internship she had the opportunity to experience the extensive work of NAFO and the NAFO Secretariat.

At the Secretariat, Yumi worked with the Science Team, doing preparation and follow-up for the Scientific Council June meeting. She also arranged the daily catch reports to demonstrate catch and bycatch trends, and cluster analysis, to consider species association in each NAFO division, with the Fisheries Team. Additionally, Yumi had the opportunity to be involved with fine-tuning the new NAFO website and with assisting the Outreach Team. Yumi also attended a meeting of the Joint Advisory Group on Data Management, the NAFO Scientific Council Meeting, the NAFO Ad Hoc Working Group on Bycatches (WG-BDS), and the NAFO Joint

Fisheries Commission-Scientific Council Working Group on the Ecosystem Approach Framework to Fisheries Management (WG-EAFFM).

Martha Astrup

Martha came to the NAFO Secretariat for a three-month internship from August to late October 2016. She hails from Norway where she worked in the Ministry of Trade, Industry and Fisheries.

During the course of her internship, Martha will have the opportunity to gain an international experience with a Regional Fishery Management Organization and contribute to various office duties and research in all areas and functions of the Secretariat under the supervision of the Senior Fisheries Commission Coordinator and the Fisheries Information Administrator.

She will assist in the tasks pertaining to NAFO Conservation and Enforcement Measures, specifically, processing of observer reports and haul-by haul catch submissions, quota uptake monitoring through the VMS, catch and bycatch analysis, summary graphs and figures for the Draft Compliance Review, etc.

In addition, Martha will have the opportunity to assist at the 2016 Annual Meeting of NAFO.

Outreach

Media

The Secretariat continued to circulate its annual press releases to a dedicated NAFO media contact list. This year, a press release was circulated shortly after the publication of the report of the June Scientific Council meeting. Additionally, a press release will follow the closing of the Annual Meeting.

External Relations

During the past year, Executive Secretary - Fred Kingston has participated in meetings to discuss NAFO-related issues, including the following:

The NAFO Secretariat continues to hold smaller working group meetings in its boardroom whenever possible as well as offer the use of the space to affiliated groups for a nominal fee. In the past, universities and Fisheries and Oceans Canada have used the space for meetings including the joint Working Group on the Northwest Atlantic Regional Sea (WGNARS) held 23-27 Feb 2015.

International Oceans Day

The NAFO Secretariat continued to participate in World Oceans Day 2016. Two Secretariat staff members, Jana Aker, Fisheries Information Administrator, and Yumi Okochi, NAFO Intern, attended the local Oceans Day in Halifax, Nova Scotia on Friday, 3 June at the Maritime Museum of the Atlantic on the Halifax waterfront.

Information Requests

The NAFO Secretariat regularly responds to requests from various international sources. During the last year the Secretariat has responded specifically to:

- Request for input on the web-based questionnaire for monitoring the implementation of the 1995 FAO Code of Conduct for Responsible Fisheries, the International Plans of Action on Capacity, Sharks, Seabirds, Illegal, Unreported and Unregulated Fishing and the Strategies for Improving Information on Status and Trends of Capacity of Capture Fisheries and Aquaculture.
- Request for input to the UN Secretary-General's Report on oceans and the law of the sea, Part I, pursuant to the UNGA draft resolution A/70/L.22 on "Marine Debris, plastics and microplastics".

- Request for input to the UN Secretary-General's report on the actions of States and regional fisheries management organizations and arrangements addressing the impacts of bottom fishing on vulnerable marine ecosystems.
- Request for contributions to "an inventory of available information on recent and ongoing assessments and other processes at the regional and global levels relevant to the Regular Process for Global Reporting and Assessment of the State of the Marine Environment, including Socioeconomic Aspects," pursuant to paragraph 286 of General Assembly resolution 70/235 on "Oceans and the law of the sea" (provisionally available as A/70/L.22), adopted on 23 December 2015.
- Contribution to the Regional Fishery Body Secretariats Network (RSN) Newsletters.

Throughout the year various informal requests are made to the Secretariat regarding specific information, procedures of NAFO, etc. by students, educational institutes, RFMOs, Contracting Parties representatives or other organizations. These are answered to the best of the ability and as time permits by various members of the NAFO Secretariat.

Oil and Gas Activity in the NRA

At the last Annual Meeting, Contracting Parties discussed Canada's information exchange arrangement. The Canadian process was seen by Contracting Parties as a reasonable approach for such an information exchange arrangement and Canada undertook to continue to engage with the Executive Secretary to consider possible refinements to its text, taking into account specific suggestions from one Contracting Party.

Since the 2014 Annual Meeting, Canada has also implemented an "interim process" through which it has sent to the NAFO Secretariat information about petroleum-related activities on Canada's continental shelf in the NAFO Regulatory Area for onward transmission to NAFO Contracting Parties. Since the 2015 Annual Meeting, there have been four such notifications.

ABNJ Deep Seas Project: 2016 World Wide Review of Bottom Fisheries in the High Seas, 3-5 May in Rome, Italy

12. Financial Status Update

The 2015 fiscal year ended in a very good financial position with operating cash at high levels and with only \$31,880 owing from one Contracting Party. Actual operating expenses for the year were 4.1% under the Organization's budget of approximately \$1.981 million. W|B|L|I Chartered Accountants performed the audit of the 2015 financial records for the fifth and final year of their mandate. The statements will be reviewed and approved by the Organization at the September 2016 Annual Meeting.

The NAFO budget for 2016 was increased to \$1.997 million as additional funds were required for the recruitment and relocation costs of the incoming Scientific Council Coordinator. The Secretariat has been working within the approved budget and expenditures are projected to be \$36,000 under budget for the 2016 fiscal year (see page 10 - Statement I of the Financial Statements). As of 24 August 2016, there was \$73,804 in membership contributions outstanding from one Contracting Party (see page 12 - Statement III of the Financial Statements).
