Taking into account the recommendations of the IOC Working Group on Ocean Data Stations of 30 March 1966 (Doc. AVS/9/89E-ODS, Item 8) and also the recommendations of the 6th Meeting of the IOC Bureau with the Consultative Council of 18 May 1966 (Doc. UNESCO/IOC/B-25, Rec. 6.6 -6.10),

Basing itself on the fact that the legal aspects of such broad problems as investigations of the oceans and use in this connection of autonomous floating stations, buoys, and other devices collecting oceanographic data, and also the legal aspects of the exploitation of mineral marine resources, have not yet found their interpretation in any of the international conventions actually in force,

Taking into account the importance of these legal aspects and also the necessity to implement the recommendations quoted above.

Proposes to the IOC Bureau and Consultative Council the following:

- 1. To create a special working group of the IOC on legal aspects of studies of the ocean and utilization of oceanic resources, composed of representatives of six to eight Member Governments of the IOC, which representatives would be well qualified specialists in the field of international maritime law.
- 2. To charge this group with the responsibility to prepare drafts of the following documents :
 - a) A convention on the basic principles of conducting scientific research on the high seas and using for this purpose autonomous data-collecting stations;
 - b) A convention on the international norms of exploration and exploitation of the mineral resources of the high seas.

It is understood that these projects, after having been developed by the working group, should be circulated for study to all IOC Members and also to those governments non-Members of the IOC who might be interested in resolving these problems.

- 3. To ask the above-mentioned IOC working group, in addition to working out these two draft conventions, to provide the IOC Secretariat with advice on legal aspects of scientific studies of the ocean.
- 4. To ask the Fifth Session of the IOC to consider calling, following the initiative of the IOC, an International Conference, in which all the interested States of the world would participate, in order to discuss and adopt the abovementioned conventions.
