SCIENTIFIC COUNCIL MEETING - JUNE 1984

Report of the Ad Hoc Inter-Agency Consultation on Atlantic Fishery Statistics,

8-9 October 1983, Gothenburg, Sweden

- This meeting of the inter-secretariat ad hoc consultation took place on 8-9 October 1983, Gothenburg, Sweden. As CWP Secretary, Mr. E. F. Akyuz opened the consultation and was elected Chairman.
- 2. The participants in the meeting are titled in Annex C.
- 3. The draft agenda was presented and adopted (see Annex A).
- 4. The list of documents discussed at the consultation is given as Annex B.
- 5. The ICCAT participant reported that on a number of occasions his organization had not received CWP correspondence. Measures proposed to remedy the situation included improved liaison between the ICCAT and ICSEAF secretariats and the increased use of telex (if only to announce the sending of correspondence by the post). FAO and other agencies would investigate an extended use of its computer conferencing system.
- 6. The consultation reviewed and approved of the progress made in the implementation of CWP-11 recommendations and proposals, most of the work being on schedule for the deadline of the CWP-12 Session.
- 7. The consultation in considering the arrangements for the CWP-12 Session asked the ICES Secretariat to arrange a block booking at the Comfort Hotel in Copenhagen. Member agencies were asked to confirm the bookings at the earliest opportunity.
- 8. The draft agenda and draft annotated agenda for the CWP-12 Session (documents AHIC-AFS/83/11 and 12) were discussed and approved with a few minor revisions. The revised documents appear as Annexes D and E of the present report. The responsibility for the preparation of distribution of CWP-12 documents was agreed (see Annex F).
- 9. The consultation considered that document AHIC-AFS/83/6 containing revisions to the form of the questionnaire on conversion factors met the request of CWP-11 that conversion factors be processed as time series and asked FAO to proceed with the collection and processing of the data on such a basis.
- 10. In considering document AHIC-AFS/83/9 on a harmonized format for the transmission between agencies of data on magnetic tape the consultation considered that records should be of fixed, rather than variable, length and that tapes should be without label. It was agreed that EUROSTAT, in consultation

with ICCAT, would distribute a questionnaire on which agencies would record their requirements for the form and contents of the records. A task force would be established a the CWP-12 Session to further develop the harmonized format.

- 11. The consultation approved the progress EUROSTAT had made in developing a method of detecting discrepancies in databases (document AHIC-AFS/83/7) and requested that this very necessary work be continued.
- 12. The consultation discussed how statistics on socio-economic aspects of fisheries may be handled by the CWP and considered that the first topics to be given initial attention should be data on quantity and value of landings, fishermen statistics and fishing fleet statistics.
- 13. The ICES participant introduced document AHIC-AFS/83/16 proposing changes to the STATLANT 27A and 27B questionnaires requesting submission of data by the sub-divisions of the International Baltic Sea Fisheries Commission. The consultation approved this change and asked the ICES Secretariat to inform FAO of the changes required to the STATLANT 27A and 27B forms to implement both this change and those resulting from the introduction of the STATLANT AQ questionnaire in time for them to be included in the questionnaires to be distributed in early 1984.
- 14. The OECD participant presented document AHIC-AFS/83/15 on the national definitions used in fishermen statistics. The consultation agreed that internationally harmonized system of statistics would be difficult to achieve and proposed that the CWP should concentrate on systems of fishermen statistics associated with the sector of the industry in which they work.
- 15. Mr. Pope outlined progress in a report he was preparing for FAO on the requirements for planning, designing and implementing log-book systems. The consultation approved the schema and agreed to send Mr. Pope comments on his draft report by the end of October.
