SCIENTIFIC COUNCIL MEETING - JUNE 1995

Notes on Acquisition and Publications of Statistics Since June 1994

1. STATLANT Data

In accordance with Rule 4.4 of the Rules of Procedure of the Scientific Council, the deadline dates for submission of STATLANT 21A data and 21B data for the preceding year are 15 May and 30 June, respectively.

The STATLANT 21B data constitute the final catch and effort data for the compilation of the NAFO Statistical Bulletin.

The STATLANT 21A data are the provisional catch statistics, which are used extensively during the Scientific Council Meetings of June each year for stock assessments and other scientific evaluations, and are used for the compilation of meeting documents such as "Nominal Catches in the Northwest Atlantic" and "General Fishery Trends for the Northwest Atlantic".

The timely submission of STATLANT data by Contracting Parties and non-Contracting Parties fishing in the NAFO Convention Area are key to the work of the Scientific Council.

The following table provides the status of report submissions:

a) Publication of NAFO Statistical Bulletin, Vol. 41

Data for 1991 were finalized in the absence of data from France (St. Pierre and Miquelon), and published in NAFO Statistical Bulletin, Vol. 41, in February 1995.

b) Publication of NAFO Statistical Bulletin, Vol. 42

Data for 1992 have been received from all countries and components with the exception of France (Metropolitan) and France (St. Pierre and Miquelon). The data are presently being finalized for publication in NAFO Statistical Bulletin, Vol. 42, in July 1995.

c) Publication of NAFO Statistical Bulletin, Vol. 43

Data not received for 1993 to date are listed in Table 1 above.

Deadline for submission of STATLANT 21B reports for 1993 was 30 June 1994. As of May 1995, data were still outstanding from Canada (N), Faroes, Norway, EU (France - Metropolitan, Portugal), France (St. Pierre and Miquelon) and USA. We are also awaiting clarification of reports from Japan, Russia and Lithuania.

d) Provisional data

Provisional data for 1993 were received well after the deadline date and many components were not available for the June 1994 Meeting. The publication of the SCS Doc. 94/24 was completed only in November 1994.

Provisional data for 1994 are still outstanding from many countries and components (Table 1), and the compilation of the SCS Document in time for the June 1995 Meeting of the Scientific Council may not be possible.

e) <u>Historical Catches for 1983-93</u>

The Secretariat continued the practice of preparing decadal catch data. The Summary Document (SCS Doc. 95/5 Serial No. N2502) contains an 11-year time series from 1983 to 1993 with updates for 1983-91 and provisional data for 1992 and 1993. More than 70 stocks are currently included in the list (others may be added upon request).

f) Catches of Selected Species by Stock Area and Country, 1960-90

A supplemental issue to the NAFO Statistical Bulletin was published in April 1995.

The Secretariat has for many years routinely published tabulations of the catches of selected species considered to be relatively important commercially, by stock area and country. After a Summary Document (SCS Doc. 86/2) which presented data for the 22-year series from 1963 to 1984, annual publications have presented 11-year tabulation updates for 1975 to 1985, 1976 to 1986, etc. in SCS Doc. 87/3, 88/1, 89/7, 90/1, 91/1, 92/5, 93/5 and 94/1. The data presented in the SCS Doc. publications may at times have been subsequently revised, as corrections and clarifications were received at the Secretariat. The data presented in this publication are the current updated figures available at the NAFO Secretariat, and constitute catch records for the period 1960 to 1990.

2. Biological Sampling

The Secretariat continued the practice of preparing the List of Biological Sampling Data. The Summary Document (SCS Doc. 95/11, Serial No. N2514) contains a provisional list of sampling data for 1993 available at the Secretariat as of $\underline{1}$ June 1995. Data for 1992 were presented in SCS Doc. 94/8 containing data available at the time of the June 1994 Meeting.

List of Fishing Vessels, 1992

Data for the triennial *List of Fishing Vessels* for 1992 were requested from all countries in January, 1993. As of <u>1 June 1995</u>, 11 reports have been received with another 11 still outstanding.
