SCIENTIFIC COUNCIL MEETING – JUNE 2007

Proposed Format Changes to the NAFO Meeting Reports and SC Redbook

CURRENT FORMAT:

Currently, meeting reports consist of various contributions from individual scientists which are compiled into one finalized report. These collected works usually contain formatting codes and other background information specific to each user's computer. When the information is compiled these background codes are then added to the master document, often creating difficulty in formatting and increasing overall document size. When the Secretariat formats the complete document, the background codes are cumbersome and create many problems, especially when standardizing documents to a specific format.

The following existing formatting will be maintained:

- The two columns of the species summary reports.
- The bold and italics used for recommendations.
- The inclusion and labeling of figures and tables.
- The overall layout of the sections in the annual compilation i.e. Part A June SC meeting, Part B September Annual meeting, Part C November NIPAG meeting, Part D Miscellaneous, etc.

PROPOSED FORMAT CHANGES:

The Secretariat will continue to compile the document during the meeting as quickly and efficiently as has been done in the past. A completed version of the draft report will be ready for distribution on the final day of the meting as is usual. After the meeting, however, the Secretariat want to compile the report using the modern formatting features e.g. outline headers, Table of Contents, etc. Immediately following the meeting the Secretariat proposes to apply formatting changes to the final document that will, with a few minor exceptions, make the document appear exactly the same but will significantly reduce time and effort required in future document preparation by the Secretariat.

- Before the report is dispersed to the Chairs and others for final editorial comment, the document will be stripped of its code and templates will be applied. The Chairs will then be able to work on a "cleaned up" copy of the document using the track changes. Comments from various sources can be easily incorporated.
- The most visible change will be the reduction in the use of indentation.
- Appendices, etc. will follow on the next available page, rather than beginning on a right-hand page. This format reduces blank number of pages, and decreases total number of document pages.
- New sections will always begin on a right-hand page.
- By assigning "clean code" it will be possible to generate a correctly paginated Table of Contents.
- To make it easier to locate specific agenda items, a detailed section-specific Table of Contents will be found at the beginning of each section in addition to the full Tables of Contents at the beginning of the document.
- To eliminate the use of subscripts and italics for variables and abbreviations e.g. Blim (not *B*_{lim}), F (not *F*), et al. (not *et al.*), e.g. (not *e.g.*), etc.
