The United States Report on the
Operation of the 10% Annual Exemption to the
Mesh Regulation through 1963⁶²

The ten percent annual exemption has now been in effect for five years, and the tables in this report present comparative data for each of these years except that the figures for the fifth year (1962) are for a slightly different 12-month period.

The number of certificates held had increased in 1961, but dropped off somewhat in 1962 (Table I). An analysis of landings of exempted vessels is presented in Tables 2 and 3; Table 2 showing landings from all Subareas and Table 3 only landings from Subarea 5.

Although vessels obtain the 10% annual exemption certificate in order to permit them to land haddock in amounts equal to 10% of their annual landings of all species, the total landings of haddock from Subarea 5 in 1962 by all exempted vessels was only 5.2 percent of the total of all species, and has decreased each year since the exemption was put into effect.
