# ANNUAL MEETING - JUNE 1964

Status of Proposals for Amendments to the Convention and for International Regulation of the Trawl Fishery

The following account, with appendices, reviews the present (30 April, 1964) status of proposals adopted by the Commission for changes in the International Convention for the Northwest Atlantic Fisheries 1949 and for international regulations of the trawl fishery.

- I. Re proposals for changes in the Convention.
  - (i) Change to allow Annual Meeting to be held in any member country.

Note: The Commission adopted this proposal 11 June, 1955 which resulted in an amendment to Article II 5 of the Convention. The amendment entered into force 11 January 1959.

(ii) Declaration of understanding of text of Convention concerning molluscs.

Note: The Commission adopted this proposal 14 June, 1958 and it entered into force 5 June, 1963.

(iii) Resolution to bring harp and hood seals under provisions of the Convention.

Note: The Commission adopted this resolution 9 June, 1961. The status of this pending proposal is shown in column 'a' of Appendix A.

(iv) Changes to allow proposals for national and international measures of control.

Note: The Commission adopted this resolution 7 June, 1963. The status of proposed amendments to Convention Article VIII paras. 5 and 8 are shown in column 'b' of Appendix A.

- II. <u>Re proposals for international regulation of trawl fishery</u>
  - (i) Regulation of the haddock trawl fishery in Subarea 5. (4 1/2" mesh size; 5000 pound or 10% exemption; savings gear protection).

Note: Proposed at the 1952 Annual Meeting and effective 13 June 1953 for all Contracting Governments.

 (ii) Amendments to regulation of the haddock trawl fishery in Subarea 5. (Mesh measurements).

Note: Proposed at the 1953 Annual Meeting and effective 1 January 1954 for all Contracting Governments.

(iii) Regulation of the cod and haddock trawl fisheries in Subareas 3, 4 and 5: for Subarea 5 the regulations substitute the ones adopted by the Commission at the 1952 and 1953 Annual Meetings [see (i) and (ii) above]. (4 1/2" mesh size for Subarea 4 and 5 and 4" for Subarea 3, 5000 lb or 10% exemption; savings gear).

- Note: Proposed at 1955 Annual Meeting and effective 29 November, 1957 for all Contracting Governments.
- (iv) Amendments to regulations of the cod and haddock trawl fisheries in Subareas 3, 4 and 5, adopted by the Commission at its 1955 Annual Meeting [see (iii) above].
  - Note: Proposed at the 1956 Annual Meeting and effective 1 January, 1958 for all Contracting Governments.
- (v) Amendments to regulations of the cod and haddock trawl fisheries in Subareas 3, 4 and 5 adopted by the Commission at its 1955 and 1956 Annual Meetings [see (iii) and (iv) above].

### (attaching savings gear)

- Note: Proposed at the 1957 Annual Meeting and effective for Subarea 5 28 September, 1958, and for Subarea 4 22 April, 1960 (see column 'a' of Appendix B). Further acceptance of these 1957 proposed amendments to regulations for Subarea 3 and the UK and USSR reservations thereto (see columns 'b' and 'c' of Appendix B) need not be sought since the amendments and reservations thereto have been superseded by the proposals adopted by the Commission at its 1961 Annual Meeting.
- (vi) Regulation of the groundfish (cod, haddock, redfish and halibut) trawl fishery in Subareas 1, 2 and 3 (except redfish in 3N, 3O and 3P): for Subarea 3 the regulation substitutes the ones adopted by the Commission at the 1955, 1956 and 1957 Annual Meetings [see (iii), (iv) and (v) above.]
  - $(4 \ 1/2"$  mesh size; mesh measurements; 10% exemption in 3N, 3O and 3P; savings gear).
  - Note: Proposed at the 1961 Annual Meeting. The present status of this proposal is shown in columns 'd' and 'f' of Appendix B. Column 'f' shows UK reservations on account of stern trawlers.
- (vii) Regulation of cod, haddock and flounder trawl fisheries in Subarea 4;
  substitutes for regulations adopted by the Commission at the 1955, 1956
  and 1957 Annual Meetings [see (iii), (iv) and (v) above].

 $(4 \ 1/2"$  mesh size, mesh measurements, 5000 lbs or 10% exemption; savings gear).

Note: Proposed at the 1961 Annual Meeting. The present status of this proposal is shown in column 'a' of Appendix B.

(viii) Amendment to regulation of the groundfish (cod, haddock, redfish and halibut) trawl fishery in Subareas 1, 2 and 3 adopted by the Commission at the 1961 Annual Meeting [see (vi) above].

Note: Proposed at the 1963 Annual Meeting. The present status of this proposal is shown in column 'g' of Appendix B.

 (ix) Amendment to regulation of cod, haddock and flounder trawl fisheries in Subarea 4 adopted by the Commission at its 1961 Annual Meeting [see (vii) above].

(x) Amendments to regulation of cod and haddock trawl fisheries in Subarea
 5 adopted by the Commission at its 1955 Annual Meeting [see (iii) above].
