According to the Convention, Article IV.2, "Panel representation shall be reviewed annually by the Commission, which shall have the power, subject to consultation with the panel concerned, to determine representation on each panel on the basis of current substantial exploitation in the subarea concerned of fishes of the cod group (Gadiformes), of flatfishes (Pleuronectiformes), and rosefish (genus Sebastes), except that each Contracting Government with coast-line adjacent to a subarea shall have the right of representation on the Panel for the subarea".
